### A MESSAGE FROM THE MANAGING DIRECTOR

At AESI a significant part of our fire safety business is carried out in factories and warehouses on large industrial estates. Recently I was reminded by a commercial builder and investor that the Covid disruption had caused a change in many business operations with new business plans and survival strategies being developed at the expense of workplace safety practices.

He told me that as a result of the 3 year pandemic, many business's suffered enormous losses as their supply chains were disrupted completely causing goods to perish and a resulting loss of business. Fearing the worst business's stacked their storage facilities to the brim but totally forgot about the safety risks this was placing on the commercial facility and its storage capacity.

An expensive lesson was learnt when his property was severely damaged one night when an unexpected onset of small electrical fires and considerable water damage besetting the factory. Without the Essential Safety Measures and equipment safety checks he was unable to prevent the severe short and long term business losses that followed.

### **DID YOU KNOW? WORKPLACE** FIRE SAFETY IS A LANDLORD RESPONSIBILITY

If you're an owner, landlord or occupier of a business or commercial premises, you'll be responsible for the workplace and its occupants including:

- Carrying out a fire risk assessment of the premises with regular reviews
- Advising staff or their representatives about the risks you've identified
- Establishing and maintaining appropriate ESM fire safety measures
- Planning for an emergency evacuation
- Provide employee information, and fire safety instruction and training

### OMG! ... WHERE'S OUR FIRE EXTINGUISHER?

Safety trumps home design every time. Hiding a fire extinguisher because it clashes with your decor will cost you valuable time if and when fire strikes. Locate fire extinguishers in plain view so even visitors will be able to find one.



They shouldn't be mounted more than 5 feet from the ground and have a one metre clearance. A location sign will make sure everyone knows where fire extinguishers are located and how to use them.

### CASE STUDY

Door blocked - no other way out!

A recent ESM audit undertaken by one of our inspectors revealed a critical rear exit door within a large restaurant, was fully blocked by sizeable and heavy boxes. Blocked pathway and blocked egress can cause a potential fire trap. This example is illegal, can be costly if not rectified and constitutes a serious threat to customers and staff trying escape an internal fire.

#### A RECENT LANDLORD QUESTION

- **Q** If an injury occurs in my warehouse, is the Landlord or the tenant liable in any way?
- As a general proposition, liability for injuries sustained by an entrant on commercial premises will primarily rest on a tenant-occupier, rather than the landlord. However, each case will be determined on its facts and often be based on whether the tenant or the landlord have breached their duty of care. For example, if owners of commercial premises have undertaken renovations, they must ensure they use appropriately qualified tradesmen and make relevant enquiries to ensure there are no breaches of relevant building standards.

## ADDRESSING A CUSTOMER QUESTION ON ASBESTOS

- **Q** Two Fire doors in our building contain ASBESTOS. Should they be replaced?
- A spart of their commitment to workplace safety many landlords are conducting routine replacement of old asbestos fire doors that are in disrepair and need new hardware. However providing they are in good condition and functioning under the Australian fire door requirements you may not need to replace them.

However beware! Asbestos is a dangerous product and if you are in doubt AESI can offer qualified ASBESTOS inspections and professional ASBESTOS removal.

### OUR SPRING SAFETY TIP

Now is the time for commercial property managers/ owners to identify and assess all potential fire hazards in the business and understand the risks associated with lack of Essential Safety Measure maintenance and improper use. Local fire, council and emergency authorities randomly inspect commercial premises and can issue fire safety notices authorising the immediate changes you will need to make.

# ANNUAL BUILDING SAFETY AUDITS ARE REQUIRED BY LAW

Owners or their authorised managing agents are required by law to prepare an annual Essential Safety Measures (ESM) report outlining important annual safety maintenance carried out on their building. It is a legal requirement, and failure to produce a building safety audit could void building insurance and attract council penalties.

The building surveyor or the chief fire officer is responsible for the enforcement of these regulations and non-compliance can result in substantial fines and difficult insurance issues.
